### **About the Seminar**

A notable feature of the Indian Constitution is the way in which the normal peace-time federalism can be adapted to an emergency situation. The framers of the Constitution felt that, in an emergency, the Centre should have overriding powers to control and direct all aspects of administration and legislation throughout the country.

Proclamation of emergency is a very serious matter as it disturbs the normal fabric of the Constitution and adversely affects the rights of the people. Such a proclamation should, therefore, be issued only in exceptional circumstances and not merely to keep an unpopular government. Art. 356 has been invoked a number of times since the advent of the Constitution of India. This year we saw this scenario play out twice – first in Arunachal Pradesh and then in Uttarakhand.

The main aim of this seminar is to foster an academic dialogue, promotion of research studies and publication, sharing of information and knowledge on issues relating to imposition of Presidential rule.
