Educational Qualifications :

Essential :

- (i) A post graduate degree in any discipline from a recognized university/institution,
- (ii) Doctorate in any subject from a recognized university/institution,
- (iii) Published work as evidenced in authoring of Books or Original research articles published in reputed international or national journals.

Desirable :

- (i) A formal degree in any allied/related discipline.
- (ii) Participation in National and International Seminars/Conferences etc. and presented papers independently,
- (iii) Practical knowledge of English, Hindi and Marathi.

Experience :

Academic : A distinguished academician, with a minimum of ten years of experience as Professor in a university system or ten years of experience in an equivalent position in a reputed research and/or academic administrative organization.

Administrative :

- (a) 5 years administrative experience as Dean of Faculty/Principal of a Post Graduate College/Vice Chancellor of a University/Head of the University Department.
- (b) Sound administrative acumen, leadership qualities with vision and foresight.
- (c) Familiarity with government policy, rules and procedures.

Tenure : 5 years

- a) Provided that notwithstanding the expiry of the said period of 5 years, he/she can continue in office till successor is appointed and assumes office, but not beyond six months, with prior approval of the Chancellor.
- b) Provided further that a person appointed as Vice Chancellor shall retire from office during tenure of his/her office or extension thereof, if any when he/she completes the age of 70 years.
- c) If the office of the Vice Chancellor becomes vacant due to death, resignation or otherwise and in his/her absence due to illness or any other cause, the Pro Vice Chancellor, and in his/her absence, the senior most Professor shall perform the duties of the Vice Chancellor until the existing

Vice Chancellor resumes duties or an alternative arrangement is made to entrust additional/current charges with the approval of the Chancellor.
